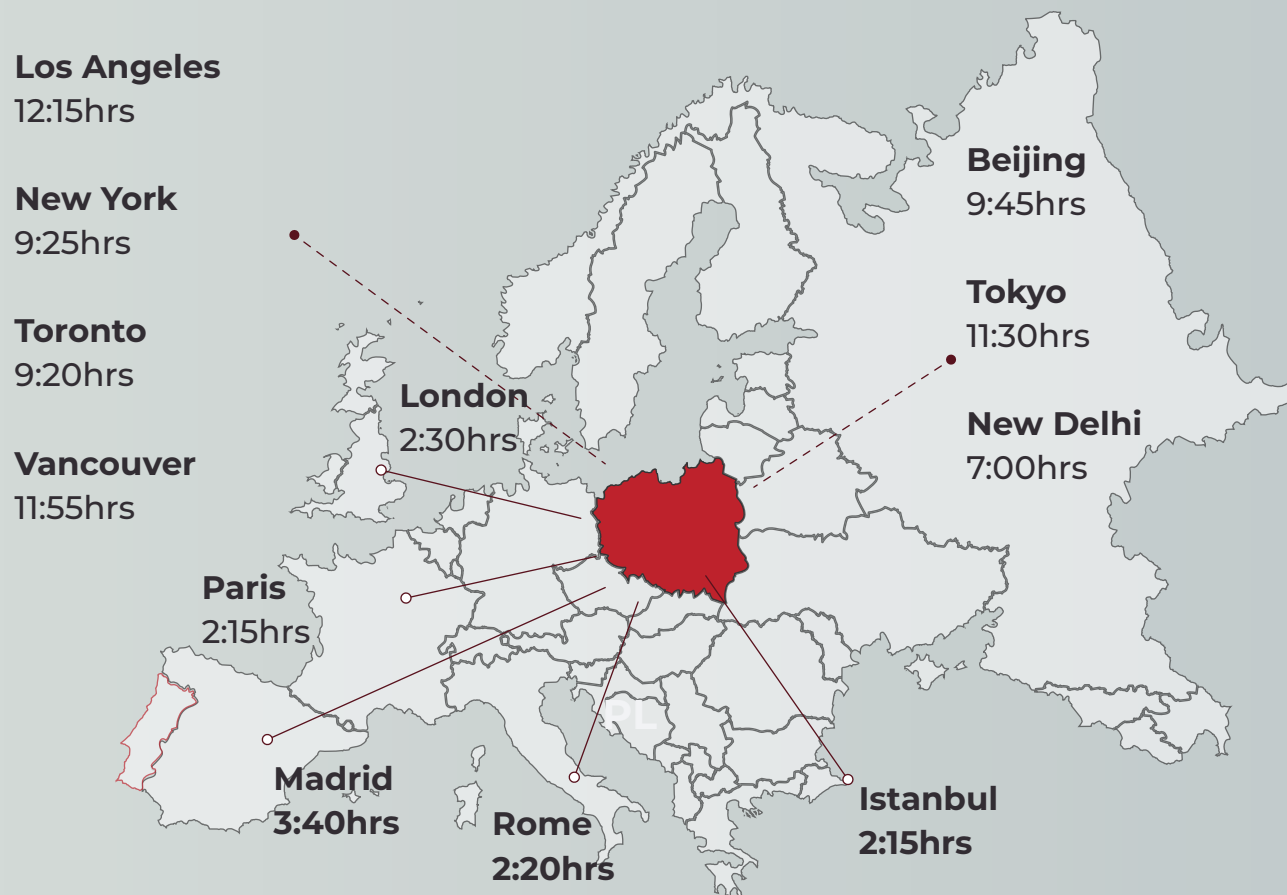

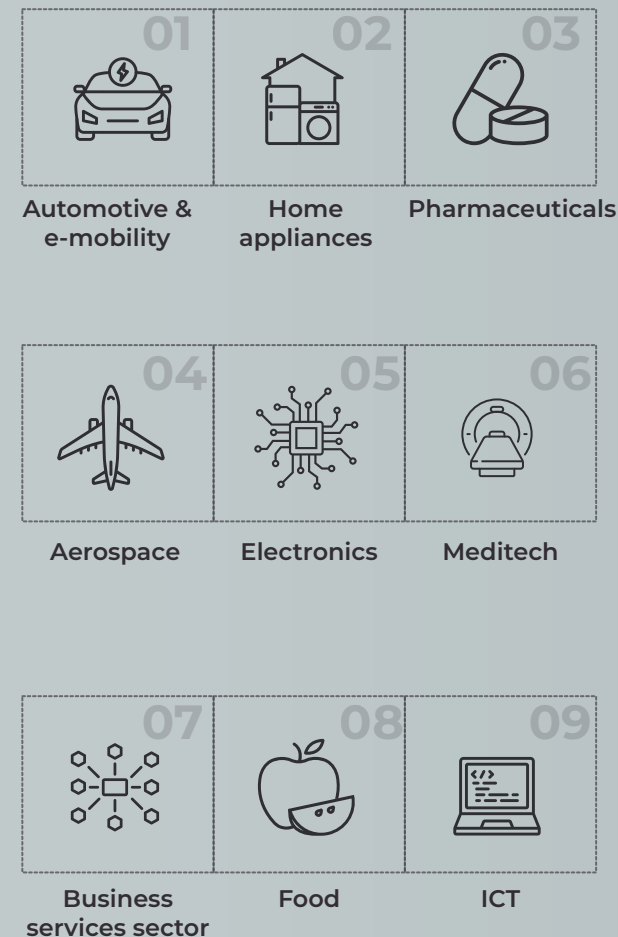
STRATEGIC LOCATION IN THE HEART OF EUROPE

HIGH-POTENTIAL INVESTMENT SECTORS

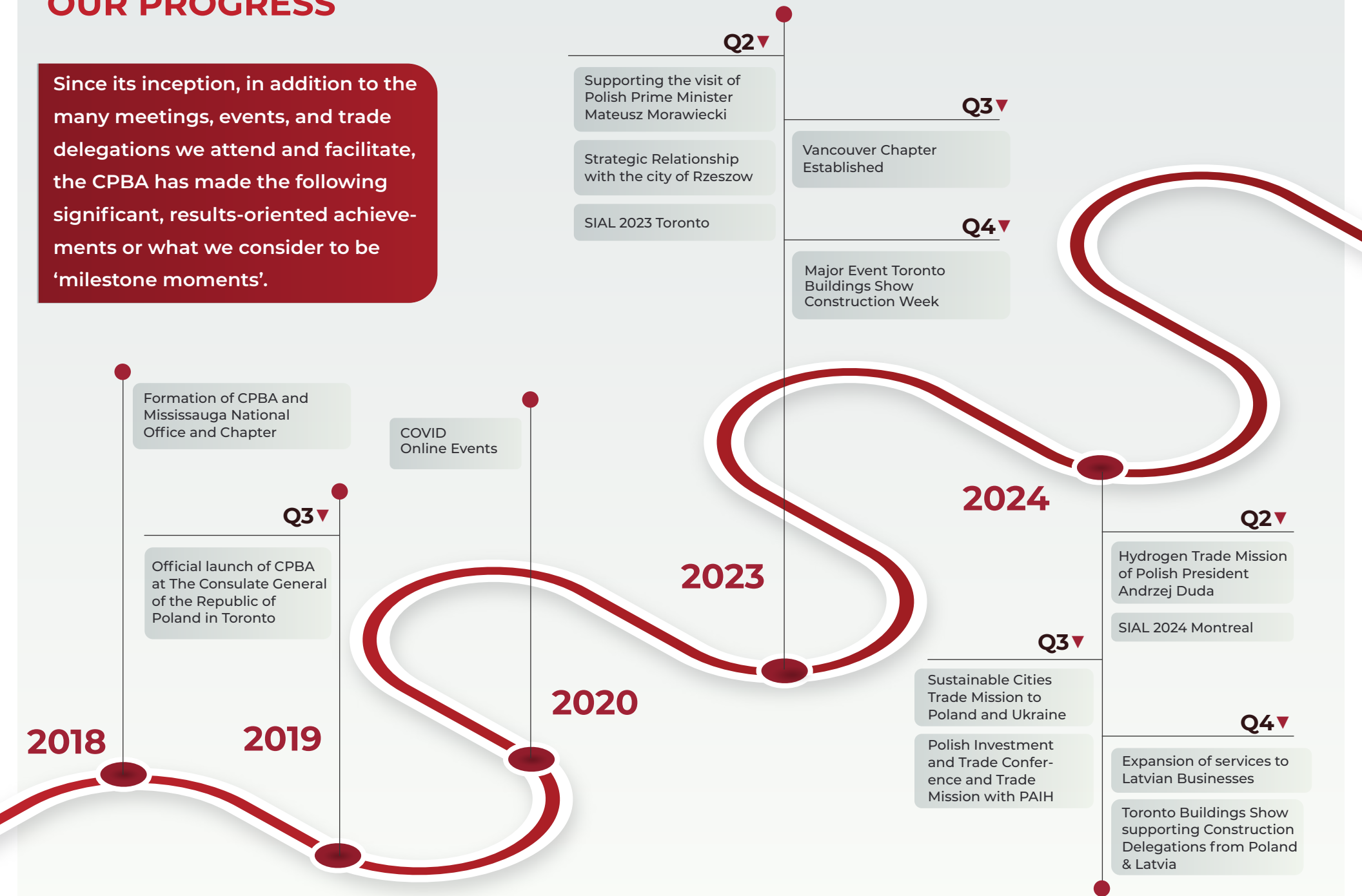
Multiple promising investment sectors with strong development potential

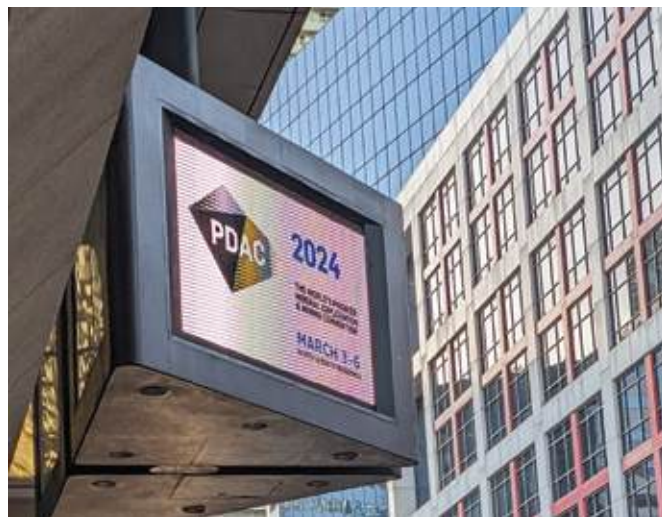

FOCUS ON FREE TRADE UNDER CETA FREE TRADE AGREEMENT

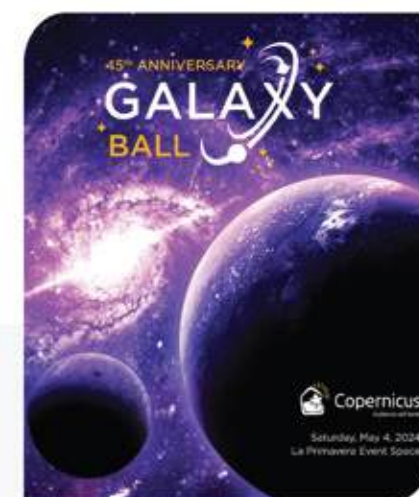

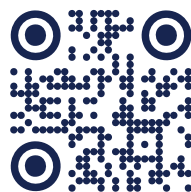
